No Russia Clause

Dear Sir or Madam,

The EU has imposed massive and unprecedented sanctions against Russia in response to Russia's war against the Ukraine.

The aim of the economic sanctions is to impose severe consequences on Russia for its actions and to effectively thwart Russia's ability to continue its aggression. Please take care of the following points of the sanction.

(1) It is forbidden to sell, export or re-export, directly or indirectly our products to the Russian Federation or for use in the Russian Federation any goods supplied under or in connection with this Agreement that fall under the scope of Article 12g of Council Regulation (EU) No 833/2014.

(2) The [Importer/Buyer] shall undertake its best efforts to ensure that the purpose of paragraph (1) is not frustrated by any third parties further down the commercial chain, including by possible resellers.

(3) The [Importer/Buyer] shall set up and maintain an adequate monitoring mechanism to detect conduct by any third parties further down the commercial chain, including by possible resellers, that would frustrate the purpose of paragraph (1).

(4) SIKO GmbH reserves the right to take legal measures if any constitute a material breach of the paragraphs (1), (2) or (3).

(5) The [Importer/Buyer] have to immediately inform SIKO GmbH about any problems in applying paragraphs (1), (2) or (3), including any relevant activities by third parties that could frustrate the purpose of paragraph (1). The [Importer/Buyer] shall make available to the SIKO GmbH information concerning compliance with the obligations under paragraph (1), (2) and (3) within two weeks of the simple request of such information.
